The South Brunswick Public Library offers notary public services for the benefit of the residents of our community. The following guidelines will be followed in the provision of notary service:

The Library provides only basic notary services. Notary service is not available at the Library for power of attorney, mortgage documents, deeds, wills, living wills, living trusts, codicils or depositions.

- Library notaries are scheduled during certain weekday and evening hours only.
- It is recommended that customers seeking notary service call the Library prior to their visit to ensure that a notary is available at that time. The Library can be reached by calling (732) 329-4000, ext. 7290 or ext. 7286.
- There is a **\$2.⁵⁰ charge per notary signature.**
- Notary service is provided on a **first-come, first-serve** basis.
- **Valid photo identification is required** of any customer seeking notary service. (ie: photo drivers license, passport)

- **The Library will not provide witnesses** and witnesses may not be solicited from customers using the Library. In order to serve as a witness, the witness must personally know the person whose document is being notarized and must be in possession of valid photo identification.
- **Documents in** any language other than English will not be notarized at this facility.
- New Jersey law requires that a notary and the customer seeking notarization be able to **communicate directly** with each other. Library notaries are not permitted to make use of a translator to communicate with a notary service customer.
- **In accordance with New Jersey Notarial Law**, notaries will not provide service if the customer, document or circumstances of the request for notary service raise any issue of authenticity, ambiguity, doubt or uncertainty for the library. In this event, the library notary may, at his/her sole discretion, decline to provide notary service.
